

**NOTICE OF SPECIAL ELECTION
SCHOOL DISTRICT OF MILTON
NOVEMBER 7, 2017**

NOTICE IS HEREBY GIVEN, that at an election to be held in the School District of Milton on November 7, 2017, the following question will be submitted to a vote of the people:

"Shall the School District of Milton, Rock and Jefferson Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$69,900,000 for the public purpose of paying the cost of a District-wide school building and improvement program consisting of construction of an addition at East Elementary School; conversion of the current high school to the middle school; construction of a new high school and related site improvements on land adjacent to the current high school owned by the District; renovations and improvements to provide for reconfiguration of grade levels; and acquisition of furnishings, fixtures and equipment?"

A copy of the entire text of the resolution directing submission of the question can be obtained from the District Clerk at the School District offices located at 448 East High Street, Milton, Wisconsin 53563.

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID you may obtain a free ID for voting from the Division of Motor Vehicles.

VOTING BY ABSENTEE BALLOT

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

You must make a request for an absentee ballot in writing.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the referendum. You may also submit a written request in the form of a letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application for an absentee ballot by mail, email or in person.

Making application to receive an absentee ballot by mail

**The deadline for making application to receive an absentee ballot by mail is:
5 pm on the fifth day before the election, Thursday, November 2, 2017.**

Note: Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.
