# Project Status Report for

**Period of October 24, 2019 – November 21, 2019** 

### **Design Phase Progress**

- Design Sessions were conducted on November 7, and November 21. These sessions focused
  primarily on the Middle School and High School design progress including review of classrooms,
  common areas, occupant loading, circulation, pool and gym layouts and the civil drawings i.e. site
  considerations.
- PRA is working closely with Professional Audio Designs Inc. of Wauwatosa to determine the most economical acoustical designs for the Middle School and High School band and choir rooms. PAD has toured both schools, met with staff, and is in the process of making design recommendations.
- Design Development Drawings for the Middle School have been priced by Cullen and PRA is preparing to proceed with Construction Documents pending approval of the School Board.
- The High School Design Development drawings will be issued to Cullen on 11/22 for pricing.
- The District, PRA, and HFD have met to discuss technology requirements for classrooms and common areas. Further development of these requirements and budgeting will occur in the next 2 weeks. Meetings will be scheduled with the school principals to review the design.
- FF&E (Furniture, Fixtures, and Equipment) vendors will be interviewed by the District and HFD in the
  coming weeks to determine who the District will hire to manage and price FF&E items for each
  school.

### **Construction Phase Progress**

- JP Cullen has mobilized for the new additions at East and West. Cullen has met with the Principals from both schools, established lines of communication, created emergency evacuation plans, and coordinated revised pick up and drop off locations for students. Foundation work for the East addition will start on December 2, 2019 and West will start 2 weeks later on December 16, 2019. Construction starts for both schools were delayed by weather and the state plan review, however, the new additions will still be completed on schedule due to "float" in the construction schedules.
- On-site construction progress meeting for the Elementary Schools are being held every other
  Thursday at Cullen's field office. In attendance are Cullen's project manager and field personnel, PRA,
  HFD, and the District.
- Utility relocations for East, West, and the High School are complete.
- Our anticipated construction schedule is currently:
