Recommendation on Approval of the 2017-2018 Milton Education Association Master Agreement

The Board of Education negotiates base wage salaries with the Milton Education Association (MEA) each contract year. On March 10, 2017, the Board of Education Human Resources Committee and the MEA met to negotiate for the 2017-2018 year.

The Human Resources Committee offered a 1.26% CPI-U increase to the 2016-2017 base wages for each teacher whose contract has been renewed for the 2017-2018 school year and the MEA has ratified this offer.

Upon approval, the Human Resources Department will develop the 2017-2018 salary explanations and send them to teaching staff on or before March 31, 2017.

A recommended motion would be "to approve the 2017-2018 Milton Education Association Master Agreement as presented."

2017-2018 MASTER AGREEMENT BETWEEN THE BOARD OF EDUCATION OF THE SCHOOL DISTRICTOF MILTON AND THE MILTON EDUCATION ASSOCIATION

ARTICLE 1-RECOGNITION

The Milton Education Association is recognized as the exclusive negotiating representative for all regular full-time and regular part-time certified teaching personnel and certified personnel who are directly supportive of the education function, but excluding substitute teachers, paraprofessional personnel, supervisors, managerial employees, confidential employees, and all other employees.

ARTICLE 2-DURATION

This Agreement shall be binding and in force and effect from July 1,2017, through June 30, 2018.

ARTICLE 3 - WAGES

The amount to be distributed to the employees in this bargaining unit as an increase to base wages for the 2017-2018 contract year shall result in a 1.26% increase to the 2016-2017 base wage for each teacher whose contract has been renewed for the 2017-2018 school year.

ARTICLE 4-MISCELLANEOUS

This Agreement was negotiated pursuant to the Municipal Employment Relations Act (MERA), as revised and applicable administrative regulations. It is intended to conform to state laws and regulations, including MERA and applicable administrative regulations. In the event that any provision of this Agreement is contrary to law, then such provision shall not be applicable, performed, or enforced, except to the extent permitted by law; however, the remaining provisions shall continue to be in effect.

THIS AGREEMENT WAS ADOPTED by the Board of Education for the School District of Milton and the Milton Education Association in separate meetings held by their bodies.
